WORKSHOP

Mission Bay Lease Revenue Statistics Update – Stacey LoMedico, Park and Recreation Department Director provided the Board Members with two handouts: 1) Mission Bay Lease Revenue for Fiscal Year 2011(overview of all the lease properties which are part of the Mission Bay Revenues) and the Schedule of Mission Bay Park Lease Revenue both dated April 21, 2011. Mr. Whitfield presented the two previous lease revenue updates and since there were no significant changes, Ms. LoMedico presented the third quarter Fiscal Year 2011 update.

Pursuant the City Charter the threshold for the first 2.5 million go to the Regional Park Fund which is based on one full year revenues for Fiscal Year 2011. Revenue projections look to be on target for the same revenues for next year.

Mr. Whitfield is ready to return with the recorded revenues in August if we have a meeting or September to go over the Fiscal Year 2011 year-end unaudited report.

If there are funds for regional parks the Department staff will go to the advisory committees to make recommendations and ultimately come before the Park and Recreation Board with these recommendations. The Department will be on a timeline to do the budget review before the Fiscal Year 2013 budget process next year.

Ms. LoMedico will provide a list of the Regional Parks which are all the ones in the City Charter plus Torrey Pines City Park if adopted by City Council Ordinance at the next meeting.
