INFORMATION

201. Performance Audit of the Mission Bay Improvement Fund FY 2012 Presenter: Ms. Danielle Knighten, Audit Manager, City Auditor

Ms. Knighten presented a PowerPoint presentation and reminded members that the City Auditor's office conducts this audit every year as required by the City Charter. The presentation covered the following:

- Background on the Mission Bay Lease Revenue Allocations (San Diego Regional Parks Fund and Mission Bay Improvement Fund)
- Audit Objectives
- Fiscal Year 2012 Financial Activity
- Fiscal Year 2012 Mission Bay Park Lease Revenue
- Recommendations

Committee Members had various comments and questions:

- Mr. Bussell requested clarification regarding the San Diego Regional Park Improvement Fund included transfers and investment earnings. Is there is a process that indicates funds are invested in Money Markets? Ms. Knighten responded "no" and that is a part of the allocation that the City does City-wide for interest earned on funds the City has. Every year the Comptroller's office allocates earnings on investments to the various funds.
- Chair Diehl inquired how long does a project take to complete funding balances for a
 project; specifically a CIP project. Ms. Knighten responded the Auditor's office looks at
 the expenditures associated with projects only and not the start and ending of projects.
 Additionally, Ms. Knighten added the department's that are in charge of specific CIP
 projects could better answer.
- Ms. Warburton inquired about the fund balance totals (\$5M) and the transfer totals (\$2.5M) and if they are encumbered or is it available money? Ms. Knighten responded she was unable to answer specifically, due to Park and Recreation Department projects that might be tied up. There is a specific process regarding encumbered funds.
- Ms. Warburton also inquired about Audit Objectives and the expenditures requirement under the City Charter. Is the Regional Park Improvement Fund what is being audited for consistent and compliant Charter requirements? Ms. Knighted responded the Auditor's office is looking at the San Diego Regional Parks Fund expenditure. That fund is based on an allocation from the lease revenue and there are certain restrictions.
- Ms. LoMedico commented on the recommendations in the Audit: Recommendation #1 will be critical to the Board and the Department with regard to how expenditures are reported. The Department will coordinate that response.
- Ms. Granowitz inquired if/when there is a large project, is CIP and DIF used and if so how does that work? Ms. LoMedico responded that multiple fund sources are used and she is not versed on how the funds are expended in what order. In March 2012 there were various recommendations to the 2012 Audit.

- Chair Diehl requested when the Board gets its next request for Regional Park Funds, could staff provide a breakdown of what was accomplished in the past so as to compare to what it's doing now. Ms. LoMedico advised that staff previously provided an Excel spreadsheet and it will be updated to include the status of funds, which is anticipated to come before the Committee in November.
