APPROVAL OF MINUTES OF SEPTEMBER 18, 2014

A motion was made by Mr. Brown and seconded by Ms. Granowitz to approve the September 18, 2014 meeting minutes with any necessary spelling and/or punctuation corrections as noted. The motion was approved (7-0-4).

Consent Agenda was approved unanimously (7-0-4) with four absences. Vice-Chair Stepner thanked Ms. McCain and Mr. Carter for their contributions over the years to the City Heights community.

COMMITTEE REPORTS

Community Parks I Area Committee

- Mr. Bussell reported the committee had two action items on October 1, 2014. One item was moved to the consent agenda, the termination of Washington Elementary Joint Use Agreement and renaming Robb Field to Gary Orbick Field.
- Deputy Director Kathy Ruiz provided to the committee CEQA guidelines, plus the Department Instructions (DI) 8.3 modifications.
- A workshop was provided regarding independent contractors in City parks and handling of Recreation Council petty cash.

Community Parks II Area Committee

- Mr. Hughes added that the committee approved unanimously the renaming of City Heights Mini Park to Virgie Hazel McCain and William Henry Carter Mini Park.

Balboa Park Committee

- Mr. Kinney had no report from the committee meeting as he did not attend. However, he did provide some information on the Balboa Park 2015 plans. Mr. Kinney added a press conference was held on October 13, 2014 which talked about plans for 2015. Mr. Kinney added the conference focused on enhancements to the park such as expansion of the Japanese Friendship Garden, renovation of the Botanical Building, enhancements to the Plaza de Panama, lighting of the park and greatly enhanced wi-fi.

COMMUNICATIONS

Public Comment: Ms. Suzanne Ledeboer, Normal Heights resident and a member of the Normal Heights Community Planning Group. Ms. Ledeboer attended on behalf of the Chair of the Normal Heights Community Planning Group, Ms. Caroline McKeever. Ms. Ledeboer stated the Normal Heights community will be getting two new elementary schools. The new schools plus the current

John Adams School will be taking on new challenges that the planning group feels will affect Park and Recreation. The planning group has concerns about the Adams Recreation Center and the park next to it plus the joint use field. Ms. McKeever and Ms. Ledeboer requests that the Park and Recreation Department get involved now while decisions are being made.

CHAIRPERSON'S REPORT (Vice Chair) - None

DIRECTOR'S REPORT

- Mr. Field, Assistant Park and Recreation Director announced that he was filling in for the Park and Recreation Director, Mr. Herman Parker. Mr. Parker is attending the National Recreation & Parks Association (NRPA) Convention this week. He added that other staff are attending as well.
- Mr. Field responded to Ms. Ledeboer's comments. He advised that staff is attending the coordination meetings that are occurring in the evening. Mr. Field added that Mr. Gordon Bordson, Area Manager is attending. Mr. Field advised that Park and Recreation is involved and is a part of the discussions.
- Mr. Field provided a copy and commented briefly on Mayor Faulconer's press release regarding plans for the 2015 Centennial.
- Mr. Field also commented on Mayor Faulconer's press release regarding the drought. He added that currently Park and Recreation is voluntarily complying with Drought Level 1; which restricts our watering times, length of time and when we water. Mr. Field encouraged members to report water waste via the app, including reporting City staff if you see water waste. City Council will be voting/approving the motion to move to Drought Level 2 on Monday, October 20, 2014.
- Mr. Field provided a list of all the Halloween Carnivals taking place at our various Recreation Centers.
- Events in/around the park system: Press Conference with Casa Familiar at San Ysidro Community Park October 2, 2014. Also On October 2, 2014, there was a groundbreaking ceremony at Central Avenue Mini Park in City Heights, which will have a skate plaza.
- Upcoming Event: October 27, 2014 at 10am Skyview Park will be renamed and dedicated in honor of deceased police officer Christopher Wilson.
- Mr. Field advised the Park and Recreation Department is working on a cost of service study. This study will tell us how what it costs for Park and Recreation to provide a given service and if our fee schedule is commensurate with that. It is anticipated staff will be providing this information to the board in December.
- Finally, Mr. Field stated we will poll members for their availability to have a meeting in December.

Questions/Comments from members:

- Ms. Granowitz inquired as to the progress of the clean-up after the windstorms. Mr. Field advised that all is back to normal with no major issues.

- Mr. Bussell inquired about as to the type of youth golf program planned with Community Parks I and Community Parks II. Mr. Marney stated the program anticipated to use is called Snag Golf. This would be an introduction to golfing.

- Mr. Bussell inquired as to who are the members of the Municipal Golf Committee. Mr. Marney responded the committee is Mayoral appointed, with a variety of background specialties targeted in the selection.
- Ms. Granowitz inquired if the rounds at Balboa and Mission Bay seem to be better than in previous years. Mr. Marney responded that there has been modest growth in the last three fiscal years.
- Ms. Granowitz inquired about the GDP for Balboa Golf Course. What is the status? Mr. Marney was unable to provide any details at this time.
